Student Organizations:

1. Organization Mission Statement.
2. Letter of support from a faculty advisor or school administrator.
3. Roster of active student members **over the age of 18** or the name of the sponsoring faculty advisor for minors.
4. Confirmation of recognition or registration with your school, college, or university.
5. Existing procedures of your organization must include volunteer background checks.
